Sub: Renewal of Provisional Affiliation for BAMS and BHMS Course.

Sir/Madam,

I am to convey the decision of the 109th Academic Council vide Resolution No: AC:109:2022:5:7(i) held on 28th September, 2022 which resolved grant of renewal of Provisional Affiliation for BAMS and BHMS Course for a period of 3 (three) years w.e.f. academic sessions 2022-23 to 2024-25 in continuation to the Affiliation granted vide this office letter of even No. 255 dated 30/07/2019.

The Institute is required to fulfill the following conditions as laid down by the Inspection Team:

- 1) Efforts should make to fill up vacant positions of librarian, faculty, medical officers, resident and supporting staff as per the norms of CCIM. The Institute has floated an advertisement NEIAH/ADVT/2022/01 dated 16.03.2022 for filling some posts.
- 2) The ongoing construction of buildings shall be speeded up.
- 3) High-speed internet with good wi-fi facility and CCTV security systems within the campus shall be installed or strengthened.
- 4) Outdoor sports facilities for the students, as per plan, shall be made functional.
- 5) The database of all patients from registration to revisits shall be maintained in a robust LAN supported system.
- 6) There is a need to establish herbarium of medicinal plants in the Institute. This may be done in consultation with the Botanical Survey of India and the Department of Botany, NEHU, Shillong.
- 7) The Institute shall make efforts to increase visibility and popularize itself to attract more patients both in OPD and IPD.
- 8) There should be a confidential examination office/cell established within the Institute with adequate manpower.
- 9) There shall be an Ethics and Bio-safety Standards Committee within the Institute to meet necessary guidelines.
- 10) The requirement of more space for diagnosis of patients in some departments shall be addressed.
- 11) The OPD buildings shall be made compatible for wheel-chair movement on priority basis.

12) The Fire Detection and Fire Fighting System, which is installed in the college buildings to be activated and brought under regular checking and maintenance.

13) The Inspection Team recommends that the Institute during this period for another **three years** (Session 2022-23, 2023-2024 and 2024-2025), the minimum requirement in respect of faculty, librarians, medical officers and supporting staff of both the colleges and hospitals should be fulfilled as per CCIM & CCH norms.

The fulfillment of the above conditions may be intimated to the undersigned at the earliest.

The Institute is required to apply for renewal of Provisional Affiliation **six months** before the expiry of affiliation period i.e. by **January 2025**.
